## REVEILLE - WAKE-UP CALLS

### IF I COULD TALK TO THE TROOPS

#### AN EDITORIAL

Perhaps the hardest conundrum in the current and past wars is the question of whether or not a protest hurts the troops. Very few would argue with the fact that the right to protest in general about anything is quintessentially American and democratic. Very few would argue that any question is beyond discussion.

But, when I raise my voice in protest over this particular war I am told, "Shut up! You are a traitor! Your protest hurts the troops. Your questioning the war questions their sacrifice, and says that they 'died in vain'". And the worst one of all, "You are walking on their graves."

How do I, a patriot both at heart and through demonstrable long service to my country, answer these charges? How do I act in the face of such an indictment?

The nut of the problem, of course, is that I cannot talk to the troops in these exchanges, I can only talk to their self-appointed 'defenders', often folks who believe that somehow patriotism is the blind following of the

Commander-in-chief's desires. These are most often folks who have no stake in the current game: no child or other loved one in or on their way to Iraq or Afghanistan; no service of their own; no allegiance except to some comic book idea of the Constitution and the nation.

If I could talk to the troops I could tell them that I protest for them not against them.

If I could talk to the troops I could say that your promise to defend the nation is always matched by the President's promise not to send you except to defend the nation, and only when all else has failed; and that while you have kept your oath, the President and the Legislature have failed in theirs.

If I could talk to the troops, I could tell them that we went before you and in some cases, such as any theater in WW II, we knew that we were defending the country, and that our president had sent us there only because he had to; that Congress had deliberated the issue, and that the nation's representatives – our representatives -had

decided that they must declare the war that we were fighting.

If I could talk to the troops I could tell them that even in Korea, despite claims by some to the contrary, we were on the ground, we were attacked, we were defending ourselves, and our President knew why he had us there, even if Congress couldn't deliberate their way through the issue.

If I could talk to the troops I could tell them that many of us have been where they are now; that many of us never knew why we were in Viet Nam other than in service to our sworn oath, that few of us believed that if we didn't fight the Viet Cong and the NVA they would attack us in Lafayette Park, and most wondered why our President couldn't tell us the reason and why Congress wouldn't wrestle with it at all.

If I could talk to the troops I would tell them that they should never be sent into battle ill-armed and ill-trained as is happening month after month with unit upon unit in this conflict.

If I could talk to the troops I would tell them that their families deserve to be defended at home, and that their wives and children shouldn't have to travel hundreds of miles and wait days and weeks on end for medical and other family services, shouldn't have to wonder if their pay was going to arrive, and shouldn't have to suffer loss of family homes and businesses because of someone's secret plan.

If I could talk to the troops I could tell them that no person who valorously stands up and follows his oath and his leaders' orders by going into battle, and therein perishes, dies in vain; no one wounded doing his sworn duty is wounded in vain. But I would also tell them that such death or woundings are a further charge on the malfeasance of their leaders.

If I could talk to the troops I could tell them that nothing and no one ever trivializes their sacrifice in our eyes; their and our failed military and civilian leadership is all that trivializes their sacrifice in any sense.

If I could talk to the parents and loved ones of the troops I would ask them to stand with us as we stand with their dear sons and daughters.

If I could talk to the troops I unfortunately couldn't tell them why no one else is sacrificing when they are giving all.

If I could talk to the troops I could tell them that I revere their personal nobility while I deny the nobility of their leaders' cause.

If I could talk to the troops I know that they would understand and that many of them would agree.

If I could talk to the troops I would never lie.

If I could talk to the troops.

## ASSEMBLY - PROGRESS OF THE ORGANIZATION

Part of our task is to expand our current anecdotal evidence of the failure of the system to include factual and referenced instances of such failures. ## RECALL - FEDERAL AND STATE LEGISLATION

BECAUSE OUR FOCUS IS ON LEGISLATORS AND LEGISLATION IN SUPPORT OF THE TROOPS AND THEIR FAMILIES, HERE IS A NOMINATION FOR THE FIRST MEMBER OF OUR "HALL OF SHAME", WITH THANKS TO ONE OF OUR ESTEEMED ADVISORS FOR THE INFORMATION. REMEMBER, IT'S THE PERSON NOT THE PARTY WHOM WE OPPOSE.

**NOMINEE #1** – REPRESENTATIVE JOHN T. DOOLITTLE, (R – ROSEVILLE, CA – 4<sup>TH</sup> CD)

**3/16/05:** On the Iraq supplemental funding bill, Doolittle voted for \$81 billion for the war but voted against a motion to add an immediate \$1.2 billion for veterans' health care, the amount needed to cover a shortfall for VA funding. The motion failed, 200 ayes to 229 nays.

**5/26/05:** On the Defense Authorization Act for 2006, Doolittle voted against an amendment to provide TRICARE medical benefits to all members of the National Guard and Iraq. The amendment failed, 211 to 218.

On May 26th the House also considered an Amendment to H.R. 2528, the Military Quality of Life Appropriations Act for FY06 which would have provided an additional \$53 million towards veterans' health care, including combat-related trauma care, prosthetics, assistance for war orphans, and to process claims for compensation and pensions. The package was specifically targeted to help veterans returning from the war in Iraq and Afghanistan. It was offset by cutting the next round of funding for BRAC (Base Realignment and Closure) by 9%.

With both Doolittle and Richard Pombo (R-Stockton, CA – 11<sup>th</sup> CD) voting against, it failed by one vote, 213 ayes to 214 nays.

**6/24/05:** On a vote to add \$1 billion for VA health care, Doolittle voted against the motion. The motion failed 185 to 216.

**6/28/05:** The Administration announced it had vastly underestimated the number of veterans returning from Iraq and Afghanistan who would seek medical treatment at VA hospitals.

**6/30/05:** Doolittle again voted against a motion to add \$1 billion for veterans' health care.

**7/28/05:** Finally, stung by public outcry, the House Republicans changed their position and voted 410 to 10 for \$1.5 billion in health care in the Department of Interior Appropriations bill.

### **CALIFORNIA MEMBERS PLEASE SUPPORT AB 1525 – REVISION TO THE REVENUE AND TAX CODE**

Treasurer Angelides is sponsoring AB 1525, authored by Assembly member Levine (D 40<sup>th</sup> AD – Van Nuys/Canoga Park), which will give the 21,000 members of the California National Guard a refundable income tax credit of up to \$4,000 a year for health insurance premiums to cover themselves and their families when they are in the National Guard but not on active duty. The bill finances the tax credit to National Guard members by closing the "nowhere income" loophole in California's corporate tax law, which allows multistate and multinational corporations to escape taxation in any state on income from certain transactions. The bill is revenue neutral and has no impact on California's General Fund.

The amendment that revised the original bill to meet these goals passed the Assembly on August 18<sup>th</sup>. The bill has been returned to the Appropriations Committee for action. The full text of the amended bill is available at:
