FIRST CALL - THEME OF THE ISSUE AND/OR CLIPS & QUOTES

Every issue has a theme and every theme has its arguments, pro and con. Our appeal for truth to the troops starts with truth in recruitment, including truth in reporting the results of recruitment.

A recent article cited by one of our readers, written by Tim Kane and James Jay Carafano, both veterans and staff members of The American Heritage Foundation, titled **“Debunking The Myth Of The Underprivileged Soldier”**, and available for downloading at http://www.usatoday.com/news/opinion/editorials/2005-11-27-soldier-edit_x.htm, takes exception to the reports by others, including many recruiters, that the US military is targeting the underprivileged. The article says, in part,

“According to a comprehensive study of all enlistees for the years 1998-99 and 2003 that The Heritage Foundation just released, the typical recruit in the all-volunteer force is wealthier, more educated and more rural than the average 18- to 24-year-old citizen is. Indeed, for every two recruits coming from the poorest neighborhoods, there are three recruits coming from the richest neighborhoods.”

They cite enlistment statistics for high school diplomas (98%) from periods prior to when the services publicly dropped their enlistment standards. They don't define “poorest” and “richest”, i.e., poorer or richer than what?

My curiosity gets aroused when people select years out of sequence and leave out others to make their case. I also am more concerned with what is happening right now, since it is a clearer harbinger of the future. So, I went to the website of the National Priorities Project which has the raw data for just one year, 2004, but it has all of the data, without interpretation. I picked one state from each of the six regions of the US: West, California; Deep South,

Alabama; Northeast, Massachusetts; North Central, Michigan; East Coast, North Carolina; South/Southwest, Texas. My premise was that the marks of “underprivilege” were “Median Household Income” compared to the rest of that state and the nation, and “Percentage below the Poverty Line” compared the same way. The database had both of these statistics but did not have levels of education; but levels of education on a broad sample generally track with poverty levels, even though some individuals may rise above this hindrance. The database had a specific report on the top 15 (12 in the case of Massachusetts) Counties in each state. I do not claim that this is anything other than a pseudo-random sample, but it is a pretty broad sample from around the nation, and indicative of what a statistically pure sample might show.

The key figure in the raw data is numbers of enlistees per thousand residents in the 18-24 year range. The raw figures and the county reports support the claims of the recruiters (see the last article under **TATTOO**) and others who claim that they are targeting the poor and poorly educated. As income rises, in general, recruiting falls off. The poorest of counties seem to be providing the largest number of enlistees. Further, the poor counties that are predominantly Black or contain a large Hispanic population are providing above-norm levels of enlistees. I charted the recruiting rates per thousand and the Median Family Income on these highest producing counties, and almost invariably the recruiting rate sinks as the income climbs. The trend is truly flat only in Massachusetts, a wealthy state where the income exceeds the national average in most counties. This data seems to support the argument that the military, as many recruiters have admitted, is targeting the poorest youngsters across the nation. While the data here is not cherry-picked, I cannot affirm that such a conclusion is universally accurate. I do believe that it is so, with a fairly high probability. Maybe it is just more of "figures lie and liars figure", but I don't think so. [Ed.]

Before we put word out to the media, we wanted our most dedicated supporters like you to receive early notice about a crucial campaign Operation Truth is joining.

The "[Torture Is Not US](#)" campaign, launched in conjunction with the American Progress Action Fund, is a push to get Congress to pass the McCain anti-torture amendment. On October 5, the U.S. Senate voted 90 to 9 in favor of this amendment offered by Republican Senator and Vietnam Prisoner of War John McCain. The amendment to the defense appropriations bill would outlaw torture of detainees in military custody and establish the Army Field Manual as the uniform standard for the interrogation of Department of Defense detainees.

Despite this being common-sense amendment, its final passage is in doubt, as the President has vowed to veto any legislation that contains the McCain amendment.

BENEFITS' PACKAGE MAY BE ON HOLD TILL '06

Legislation on veterans' health care and other benefits could be put in the deep freeze until next year, the chairman of the House Veterans' Affairs Committee said Wednesday.

Asked if the House and Senate will pass an omnibus veterans' benefits bill before Congress adjourns later this month, Rep. Steve Buyer, R-Ind., said, "Probably not."

This would mean the only major veterans' bill to be enacted this year would be the measure already signed into law by President Bush that provides a 4.1 percent increase in veterans' disability and survivor benefits.

80% OF MILITARY VOTED OR TRIED TO

Pentagon Cites Simpler Absentee Balloting, More Outreach

They fight and they vote.

Voter participation among members of the U.S. military reached an all-time high in 2004, reflecting a streamlined absentee balloting process and increased outreach efforts, Defense Department officials said. Nearly 80 percent of people in the uniformed armed services voted or attempted to vote in the last presidential election, according to a survey by the Federal Voting Assistance Program, which is supervised by the Pentagon. The 2004 participation rate reflected an increase of 10 percentage points from 2000 and was far higher than last year's rate for the general public, which was 64 percent.

ARMY POISED TO CUT GUARD TROOPS TO PROTECT CORE PROGRAM

Pressed to reduce future budgets beginning in fiscal 2007, the Army is poised to sacrifice three Army National Guard brigades to help prevent deep cuts to higher-priority items, including its flagship transformation and procurement program known as Future Combat Systems, according to sources.

Eliminating three brigades would reduce the Army's burgeoning personnel costs, but any troop cuts to the Army in general, and the National Guard in particular, are certain to generate stiff opposition on Capitol Hill. IRAQI ARMY 'YEARS AWAY' FROM TAKING OVER

TONY JONES: One man who definitely doesn't think Iraqi troops are up to scratch is James Fallows. In a detailed investigation published in this month's Atlantic Monthly, he tries to work out why, after three years of occupation, Iraq still has no army ready to take the place of coalition forces. He's currently in Sydney to speak at a Values and Foreign Policy Conference convened by the Lowy Institute and he joins us now in our Sydney studio. Thanks for being here.

JAMES FALLOWS, AUTHOR AND JOURNALIST: My pleasure, thank you.

TONY JONES: Well, everyone from George Bush to John Howard agrees that the overwhelming priority in Iraq is to train an Iraqi army and a police force to take the place of the coalition forces. Why hasn't that happened?

JAMES FALLOWS: I think there are several reasons. One is the job is fundamentally very hard. Even in countries with advanced military cultures, like Australia or the US, training ordinary foot soldiers is difficult and training officers takes many years of experience and education. And almost every circumstance in Iraq makes this all the harder. The heritage of Saddam Hussein, which was not really a functional army, the regional divisions, all the other things we know about, plus a lack of attention and emphasis by the US for a year or two after the occupation, which is only now being redressed.

GUARD ENTICES RANKS TO RECRUIT

The Army National Guard, battling a falloff in recruiting, is offering troops a finder's fee for lining up new soldiers

The Guard Recruiter Assistant Program, launched this week in five states, offers National Guard members \$1,000 for enlisting a recruit and another \$1,000 when the prospect shows up for basic training.

"Bring in 10 people and you can earn \$20,000," says Lt. Col. Mike Jones, deputy division chief for recruiting and retention at the National Guard Bureau.

The Army Guard and Reserve have struggled with recruiting as the Pentagon has leaned heavily on their soldiers to fight wars in Afghanistan and Iraq. Before 9/11, Guard troops counted on drilling one weekend a month and two weeks each summer — not on overseas deployments as long as 18 months and the risk of death. As of Wednesday, 123,000 Guard and Reserve troops

PERSONNEL CUTS AHEAD AT PENTAGON

The U.S. Army and Air Force are both looking to reduce current levels or delay planned increases, ahead of budget considerations. ARMY WANTS VETS BACK

WASHINGTON - For former soldiers, sailors, airmen and Marines who might be toying with the idea of getting back into uniform, the Army has a new offer: Join us and regain your old rank without repeating basic training. It's the latest twist in the Army's pitch for recruits at a time when wars in Iraq and Afghanistan are making it increasingly difficult to enlist young people and meet the Army's need for 80,000 new soldiers a year.

"It's common sense," says Lt. Col. Bryan Hilferty, an Army spokesman. For the cost of mailing a brochure to targeted former service members, the Army can open a door that had been jammed shut before.

The Army previously had welcomed back former service members, but only under conditions that made it an unattractive proposition to most, namely that they would lose their prior rank and were required to take basic training again. Starting this month, the Army sent mailings to 78,000 people who left the Army, Navy, Air Force or Marine Corps less than five years ago, including 7,000 officers, as first reported Monday by the private Army Times newspaper. They can re-enter at their former rank if they have not been out of the service for more than four years, and they are eligible for a signing bonus of up to \$19,000, depending on their skill specialty, Hilferty said. <More at: <http://www.veteransforcommonsense.org/?Page=Article&ID=5610>>

FUNDRAISER WILL HELP BRING SOLDIERS HOME

Janell Montgomery has been through the drill before. Her husband of four years, Jason, is in the Arkansas National Guard. Seeing him leave again on Nov. 8 was not easy. But in 2002, he was deployed to Texarkana, Texas, to patrol a base. Now he's

going to Iraq. "It's frightening to know that your husband is out there and you can't be there for him," she said. "It's hard to be strong." Montgomery, who works for a marketing company for Wal-Mart in Bentonville, is a soldier's wife.

So is Lisa Reading of Rogers. She, however, has not been through what Montgomery has before. But she knows he also must be strong for her two sons — Trey, 13, and Matt, 9. Her husband, Darrell, left on Nov. 10 for Fort Dix, N. J. In all, more than 100 soldiers from the 1st Battalion of the 142nd Fire Brigade's armory in Rogers Rogers will go to Iraq.

Reading and Montgomery want the soldiers of Battery C in Rogers to receive the same community support as other troops in the area did when they left for deployment. They both want to see their husbands again before they leave for Iraq. Currently, their husbands are in training at Fort Dix. Reading said her husband will acquire about four days of leave time while at the fort.

If he acquires the leave time, then he can come home. However, many soldiers who get leave cannot afford to come home. "For some of them, this is a financial burden," she said. Because of this, Reading, who is the support group leader for the wives of the soldiers, is starting to organize a fundraiser.

ADDITIONAL CLAIMS STAFF FOR VA

Washington, D.C. — Yesterday, at a full Veterans' Committee oversight hearing on claims processing at the Department of Veterans Affairs (VA), Chairman Steve Buyer (R-Ind.) heard testimony of excessive wait times for claims decisions and clear indications that VA needs more claims adjudicators.

The backlog of pending claims and the time it takes VA's Veterans Benefits Administration (VBA) to process a claim has increased over the past two years. Major concerns cited yesterday beyond the backlog of claims included:

- A lack of quality in claims decisions;
- A need for medical staff who conduct disability examinations to have a greater knowledge of health issues specific to veterans;
- The perception that some claims processors have a complacent or dismissive attitude about their work.

"Veterans just want to be treated well. They recognize that something is not right and they are making a claim. How they are treated is important. It is about quality and attitude," Chairman Buyer said.

Dr. William Jones, a retired U.S. Air Force flight surgeon, recounted his own tribulations with the VA claims process system over the past six years. Characterizing the claims process, he said, "the process is programmed to procrastinate . . . there appears to be little motivation to move the claims forward."

ADVOCATES OPPOSE HEALTH CARE COPAYMENT HIKES

Major military associations are appealing to Congress to prevent increases in health care copayments and fees for service members and retirees.

The Military Coalition, a group of 36 associations representing 5.5 million active, reserve and retired service members and their families, is concerned about the Pentagon's recent announcement of an 8.5 percent increase in premiums for Tricare health coverage for reservists.

"The changes will go into effect next month, without any discussion or opportunity for congressional review or oversight," the Coalition says in a Dec. 8 letter to Congress. SECRETIVE VA LAUNCHES NEW PTSD REVIEW

The latest "unannounced" move by the VA is a new review of PTSD diagnosis, treatment and compensation. The VA's plans came to light on November 16, just six days after they had canceled a review of 72,000 PTSD claims awarded at 100 per cent disability. Pressure from veterans' groups and Democrat members of Congress forced the cancellation.

The VA's new PTSD review was not announced by the VA. There was no VA press release. There was no VA press conference. The information was not posted on the VA web site. Information about the new PTSD review was made public in a press release

by Senator Larry Craig (R-ID), Chairman of the Senate Committee on Veterans' Affairs. The release, in part, said, "The Department of Veterans Affairs announced today that it has contracted with the Institute of Medicine (IOM) on a two-pronged approach to the examination of PTSD."

Except, the VA hadn't announced anything. They were using Senator Craig as their conduit to hand out the bad news. Since Craig's press releases don't have a high readership, this information has gone virtually unnoticed.

FOR SOME VETS, A HOME ISN'T WAITING

More local veterans are returning to find they have no place to live and little help to remedy plight

After 10 months of washing laundry and setting up showers in Iraq, Army reservist Wanda Borders couldn't wait to get back to the Bronx. She figured she'd stay with her grandmother for a few months until she found a place of her own. But without a paycheck, landing an apartment in New York's tight rental market proved nearly impossible. For more than a year, she and her young children bounced among relatives' homes, often sleeping on couches or floors. "It's very frustrating, not being able to support my family the way I would want to, depending on other people for everything," Borders said. WAR'S STRAIN WEARING ON TROOPS

WASHINGTON - Drawing lessons from his own career, Col. Mat Moten tells his students at the U.S. Military Academy in West Point, N.Y., they could one day have a duty just as important as fighting terrorism: helping rebuild an Army fractured and exhausted by a long and unpopular war.

For Moten, it's a familiar story, one he first heard as a West Point cadet in 1978. Then, the all-volunteer Army was struggling after Vietnam. "It's not a cheery message," Moten says.

It's a message also echoed last week by Rep. John Murtha, a Pennsylvania Democrat and 37-year veteran of the Marine Corps, as he called for troops to start leaving Iraq immediately.

"The future of our military is at risk," Murtha said. "Our military and their families are stretched thin. Many say that the Army is broken. Some of our troops are on their third deployment. Recruitment is down, even as our military has lowered its standards."

Although there's no agreed-upon standard to determine the war's overall effect on the military, even those who disagree with Murtha about an immediate withdrawal, including Senators such as Lindsey Graham, R-S.C., and John McCain, R-Ariz., agree that the strains on a force fighting two wars at once are obvious.

MILITARY MISLEADS PRESS, FAMILIES, ABOUT HOW 10 MARINES DIED LAST WEEK IN IRAQ

New York - Why did the U.S. military mislead the media and the families of ten Marines killed near the Iraqi city of Falluja while "on patrol" last week about how they were killed? The military announced on Tuesday that it actually happened at a "promotion" ceremony and they were not on foot patrol as initially reported.

Families of the victims immediately raised questions about the incident and it was unclear whether the site had been properly swept for explosive devices.

The Marines were in a disused flour mill on the outskirts of the city to celebrate the promotion of three soldiers, a military statement said on Tuesday.

As the ceremony ended, the Marines dispersed and one of them is thought to have stepped on a buried pressure plate linked to explosives that caused the devastating blast.

But CNN, for example, reported four days ago, based on military reports, that the dead Marines "were conducting a nighttime foot patrol when a roadside bomb fashioned with large artillery shells detonated."

Recruits' Job Worries Outweigh War Fears

As sustained combat in Iraq makes it harder than ever to fill the ranks of the all-volunteer force, newly released Pentagon demographic data show that the military is leaning heavily for recruits on economically depressed, rural areas where youths' need for jobs may outweigh the risks of going to war.

More than 44 percent of U.S. military recruits come from rural areas, Pentagon figures show. In contrast, 14 percent come from major cities. Youths living in the most sparsely populated Zip codes are 22 percent more likely to join the Army, with an opposite trend in cities. Regionally, most enlistees come from the South (40 percent) and West (24 percent).

Many of today's recruits are financially strapped, with nearly half coming from lower-middle-class to poor households, according to new Pentagon data based on Zip codes and census estimates of mean household income. Nearly two-thirds of Army recruits in 2004 came from counties in which median household income is below the U.S. median.

'TROPHY' VIDEO EXPOSES PRIVATE SECURITY CONTRACTORS SHOOTING UP IRAQI DRIVERS

A "trophy" video appearing to show security guards in Baghdad randomly shooting Iraqi civilians has sparked two investigations after it was posted on the internet, the Sunday Telegraph can reveal.

The video has sparked concern that private security companies, which are not subject to any form of regulation either in Britain or in Iraq, could be responsible for the deaths of hundreds of innocent Iraqis.

The video, which first appeared on a website that has been linked unofficially to Aegis Defence Services, contained four separate clips, in which security guards open fire with automatic rifles at civilian cars. All of the shooting incidents apparently took place on "route Irish", a road that links the airport to Baghdad.
