## FIRST CALL – NOTES FROM THE FRONT

### STILL HERE BUT LONG FORGOTTEN

Every year, on or about the 4<sup>th</sup> of July, I dig out my copy of the musical 1776. I have been doing this for almost three decades, and it never fails to both amuse and inspire.

It is not historically accurate – Richard Beeman’s new book, *Plain Honest Men*” recounts incidents from the 1787 Constitutional convention that are dead ringers for incidents in the musical’s depiction of the 1776 Independence convention. Nonetheless, it is a delight. It reminds me of the time when national leaders cared very much about the future of their country.

Sadly it also reminds me that the business of war and the business of national government, while often sealed and confirmed by military action, proceeds with little regard for the soldiers executing it.

Throughout the play a young soldier arrives repeatedly bringing messages from General Washington. His troops are starving, under-clothed, unpaid, and barely armed, and no one is doing much about it. There is a line in many of his dispatches that announces his frustration:

**“Is anybody there? Does anybody Care?”**

All around us we see that soldiers today face the same attitudes as they did 233 years ago.

**Nobody’s there, for them**

**Nobody cares, for them.**

The government refuses to perform its administrative oversight, but fires whistle-blowers in the various departments who do their job for them. Witness the firing of the woman who blew the whistle at Arlington Cemetery, and the near-firing at the nuclear storage depot.

The government quibbles over soldiers manning, equipping, and especially their veterans benefits, but provides bonuses for those executives who shortchange them at every turn. While the timeliness of response to veterans’ claims went in the toilet, senior executives were collecting bonuses that could marginally support a family of three. Pay them to do their job, and when they don’t, pay them some more. What a concept!

The government cares so little for them that they shortchange maintenance, safety, and particularly health and condemns those who dare complain on behalf of their soldiers to career oblivion.

Just now our soldiers who are fighting in Afghanistan and Iraq are getting lighter weight and more effective armor to wear in 125° heat – seven years into the battle! Just before World War II, the “Jeep” program was specified by five or six soldiers in an office in suburban Virginia, and the first jeeps came off the line less than six months later. Thousands of warplanes and tanks were produced within months of the onset of the war. Now we take years to solve simple problems and then pay the lowest bidder.

The legislature likewise has abandoned its oversight, responding only when some scandal makes the front pages, and they have to react or else explain to some pretend newsperson what they were doing when they were supposed to be working. (Trips to airport men’s rooms? Journeys to Argentina? Hiding cash in their freezers? Kissing any available posterior for campaign cash?).

Legislators support giveaways of veterans land across the country because their wealthy contributors want to use the land for commercial or cost-free community needs. Meanwhile at the other end of town veterans are sleeping under highway overpasses and in

abandoned buildings – witness the West LA VA Health care center in Henry Waxman’s district.

The legislature denies benefits, or cuts benefits already in place on the sole bases of political expediency or cost-effectiveness. The Senate Armed Forces Committee just defeated an amendment to the 2010 Defense Act that would have provided treatment for autism under TRICARE. I guess it is one of those old-time events – nobody issued you autism so it’s not our responsibility.

The long-term trials of those exposed to Agent Orange, suffering from Gulf War Syndrome, exposed to Depleted Uranium, poisoned by toxic materials and waste at military installations around the globe, or most of all, fighting PTSD fit in this category as well. The legislature colludes with the Executive to deny, deny, deny and then when forced to pay attention, they demand incontrovertible proof for each soldier that he or she was exposed to the poisons, or was exposed to a “stressor” that would qualify them for assistance. All of this, of course, happening in the well-established adversarial system that presumes the invalidity of almost every claim that isn’t supported by a missing limb or a nasty scar.

The legislature writes legislation that they don’t even bother to read and allows faulty language to be promulgated as law. When the bill they gave no attention to doesn’t work, they dally over correcting their lazy errors. So now the much-touted post 9/11 GI Bill doesn’t cover any tuition in California if the university called their tuition “fees”, which most do; and California isn’t the only one with problems.

Of course we shouldn’t expect any more attention to these bills than was paid to the Patriot Act and the Military Commission Act. (What are we paying these people for?)

There is no need belaboring their incredible lack of attention to the monumental task of deliberating and deciding to declare war – they haven’t done that since 1941, so why start now?

The news media can spend forty minutes of a network or cable news show talking about celebrities and then leave the balance to “the rest of the news” – those uninteresting things like the wars in Iraq and Afghanistan, political turmoil in Pakistan and Honduras, human rights violations in Sudan, Yemen, yes even in the United States. There is no time left for the soldier or the veteran or their suffering families.

The public rightly worries about the economy, their own health problems, education and the

environment. They spend precious little time, however, worrying about those same soldiers, those veterans, or those military and veteran families who are securing their lives for them. They are great at concentrating on their own problems, but they ignore the problems of those defending them. “Out of sight, out of mind.”

As states make cuts in vital programs, the public rises up to defend their school, their hospital, their highway, their library, their job. Who stands up for the soldier? Federal government programs are not delivering, and state programs are being cut back, but if it comes to their issue or the state veterans aid program, you can bet their issue comes first. They say, “You are a veteran. Get your help from the VA”, and shut the doors to veterans in their local programs.

The veteran is always caught between those who **don’t** and those who **won’t**.

Some people step up, but often more in feel-good ways than in any way that will effect change. Sending packages to the troops or writing letters has always received modest support in communities, but that doesn’t help much if you ignore the soldier’s family that can’t make it on food stamps. He loves the cookies, but worries about his family at home.

Parades for homecoming veterans don’t do much if, at the end of the day after the paraders have gone home, the veteran can’t get needed help to get on with a life, hold a family together, get an education, get a job, and return as a fully engaged member of the community. Parades over – get on with it – you’re on your own!

A few communities are stepping up in more effective ways through specialized veterans courts for veteran offenders, and special community college programs for returning veterans. Unfortunately there are only a handful of these programs.

### A VETERAN AND THE GI BILL

Hello,

As a disabled veteran and full time student and recipient of the Montgomery GI Bill, I have an additional experience that seems to follow along the same lines. VA has announced their impending launch of the new Post 9/11 GI Bill (chapter 33) to begin on 1 August, 2009. They have repeatedly gone on the record and assured the public that unlike their notorious delay with disability claims and health care - they will certainly be ready to go on 1 August and there will be zero delays.

Now, the Post 9/11 has its own problems (for online learners and CA residents) but its birth seems to be causing a massive delay in current chapter 30 beneficiaries. For the first time in 19 months my certification link wasn't available when I logged in for the month of June to verify my attendance. After phoning the VA (and them blaming my college) I learn that they are six weeks behind on certifications. My spouse is also a student..he received the same information...and blame on the college (different than my own).

I work on a military base and am surrounded by veterans so I started asking around. I have yet to find a single student that was able to verify or certify on time. And each one of them were told that their own college was to blame.

I phoned the VA today (7/23) and was told that now they are 8 weeks behind. And in addition to them being 8 weeks behind on the certification, I'll likely have to wait an additional 8 weeks for that payment. In essence, 16 weeks to get paid for a one month period. When I asked if this was only for this month (as it was the start of the summer semester) I was told that this delay is expected to increase and carry on indefinitely. Wow, now my heart is racing.

I had already told my landlord that we were short \$2600 this month (as we both rely on GI Bill) but now I had to find a way to not only come up with that money but to do so for the next several months. My story is not unique. I work full time and also receive disability benefits so I will beg, borrow and plead and I will make it...but others cannot be so fortunate. I have to wonder, is there a connection between the projected success and timely service of the Post 9/11 GI bill and the sudden 2 month back up in current recipients? Please, speak up for the vets...our voice doesn't seem to be quite loud enough through the mouth of VA.

## **RECALL - FEDERAL AND STATE LEGISLATION AND LEGISLATORS**

### **H.R. 952, THE COMBAT ACT**

### **CAREGIVERS OF WOUNDED VETERANS COULD GET FEDERAL AID**

Momentum is growing on Capitol Hill to provide additional and consistent support to primary caregivers of seriously injured service members from Operation Enduring Freedom and Operation Iraqi Freedom.

On April 2, Sen. Daniel K. Akaka, D-Hawaii, chairman of the Veterans Affairs Committee, and ranking member Sen. Richard Burr, R-N.C., introduced Senate Bill 801, the Family Caregiver Program Act of 2009. The Department of Veterans Affairs "motto is to 'care for him who shall have borne the battle,'" Mr. Akaka said. ### **CONGRESSIONALLY MANDATED NATIONAL REVIEW OF VA DOMICILIARIES RELEASED; VA AGREES REFORM NEEDED**

July 9, 2009

WASHINGTON, D.C. – U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, issued the following statement today on a newly released congressionally-mandated national review of VA's residential mental health care facilities, dedicating the effort to a young Iraq war veteran who died in a VA domiciliary facility while receiving care for PTSD and a substance abuse disorder:

*"The tragic death of Justin Bailey after he came home from Iraq demonstrated the need for a national review of VA mental health care facilities. This report indicates what we and the Bailey family feared – some VA facilities still have not corrected the errors that may have contributed to his death, more than two years after his passing," said Senator Akaka. "I am encouraged by the Administration's full agreement with the report's recommendations, and I stand ready to assist in implementing these needed changes."*

Akaka championed Public Law 110-387, the Veterans' Mental Health and Other Care Improvements Act of 2008, a sweeping veterans' mental health care bill which included a tribute to Bailey and required this national review.

- The report, by VA's Office of Inspector General, found the following based on a national survey and random review of 20 sample sites:
- Less than half of the sites visited had appropriate policies for screening patients to be admitted into the VA residential mental health facility programs,
- Post-discharge monitoring was not evident for nearly 3-out-of-10 residents based on residential patient records, and
- An estimated 11 percent of VA Self Medication Policy patients on narcotics received more than a 7-day supply of medication.

The IG made 10 recommendations based on the review, all of which were accepted by VA. ### **FEMALE VETERANS WANT FEMALE-FRIENDLY VA**

Female veterans told a Senate panel last week that the Veterans Affairs Department often fails to provide adequate medical care to female military veterans. A Veterans Affairs official agreed.

"At the root is a system that has not been responsive to the needs of women veterans," said Patricia Hayes, the department's national director of women's health care.

The VA acknowledged that it's struggling to adapt to the unique needs of female veterans. The idea that the military should provide pap smears and mammograms is still somewhat new, VA officials said.

Beyond female-specific issues, the Senate panel was also told that, in general, getting clear answers from the VA was difficult. Army veteran Genevieve Chase, who was wounded in Afghanistan, said she was frustrated seeking help for her post-traumatic stress disorder and traumatic brain injuries. The VA Web site was unclear and the phone advice unfriendly, Chase said.

"In communicating with other veterans, I have found that I am hardly alone in this," she said. "Veterans should not need a third party to help them navigate the VA system."

### **STATEMENT OF BRUCE MCCARTNEY BEFORE THE HOUSE COMMITTEE ON VETERANS AFFAIRS**

I enrolled in the VA Independent Living Program (ILP) November 2003. Four plus years later, after constant emails, phone calls and inquiries, the process was completed.

Many other disabled veterans (Vietnam and OIF) are having similar issues as the ones I faced trying to get assistance with the ILP. The issues appear to be lack of understanding of the program by local case managers, lack of transparency (where is the paperwork in the process), lack of assistance (took months to get a reply), lack of oversight and auditing (took over four years to complete this application and that does not include a proper post-project dialogue) and pass the buck syndrome (inquiries to higher command are met with auto reply emails/letters that led to no solutions).

### **MOORE AMENDMENT WOULD PROTECT HISTORIC VETERANS PROPERTY FROM BEING PRIVATELY DEVELOPED**

Currently, the Milwaukee Soldiers' Home is on the National Park Service list to earn a place on the National Register of Historic Places.

(WASHINGTON D.C.) - The United States House of Representatives today passed a Moore amendment that would protect historic veterans' grounds in Milwaukee from potential commercial development. (see: [Group Fights to Save VA Facility for Injured Soldiers - Tim King Salem-News.com](#))

When we first examined this story in October 2007, John Lewandowski, one of the military veterans heading the effort to save the place, told Salem-News.com, "This is hallowed ground, and they want to make a buck off of it, it is wrong."

The controversy surrounding the Civil War home began in the early 1990's when Congress passed a law called the EUL or "Enhanced Use Lease" program. This allows is the VA to Sell Off any part of land or buildings that they deem "excessive" on any VA Property in the Country.

The amendment to the Military Construction and Veterans Appropriations Act for fiscal year 2010 would prohibit funds from being used to process new leases for commercial development on historic veterans' property. ### **OREGON HOUSE BILL 2744 TO BECOME LAW**

Effective January 1, 2010, employers in Oregon with 25 or more employees must provide leave during specific periods of time to certain employees who are spouses of military members serving on active duty. During a time of war, an employee whose spouse has been called or ordered to active duty is entitled to 14 days of unpaid leave per deployment, after the notification of deployment has been received but before the deployment occurs. Similarly, up to 14 days of unpaid leave per deployment is available to employees who are military spouses when the service member is on leave from deployment.

Employees who intend to take this leave must notify their employer within five business days of receiving official notice of spouse's deployment or leave from deployment. Employees will be permitted to substitute any accrued leave during their time away. The Bureau of Labor and Industries will enforce this law. If an employer fails to grant leave to an employee-spouse exercising their right to military family leave, the employee-spouse could file a discrimination or retaliation suit.

#### **DID SOMEBODY FORGET? PROTECT THE TROOPS FIRST!**

#### **NERVE GAS LEAK DETECTORS INOPERATIVE FOR YEARS ARMY REPORT CONFIRMS BLUE GRASS CHEMICAL WEAPONS DEPOT WAS "FLYING BLIND"**

WASHINGTON - July 20 - In a newly released report, the U.S. Army has admitted that the nerve gas leak monitors at a major Kentucky chemical weapons depot did not work for nearly two years. Managers at the Blue Grass Army Depot, located outside of Richmond, 30 miles south of Lexington, had rendered the detectors inoperative and the problem was finally remedied only after a whistleblower was forced to file a complaint, according to an Inspector General investigation posted today by Public Employees for Environmental Responsibility (PEER).

The Army Inspector General (IG) report, dated February 10, 2006, confirms the chief concerns raised by Donald Van Winkle, a chemical weapons monitoring operator at Blue Grass that -

- Leak detectors were improperly removed from inside the igloos holding highly lethal VX nerve gas;
- As a result, from September 2003 to August 2005 (after Van Winkle came forward), Blue Grass had no means, other than visual observation, to determine whether the odorless, colorless nerve gas was seeping from the rockets in which the agent is stored; and
- These changes were contrary to Army protocols and safety standards but only minor disciplinary action was taken against the responsible managers.

#### **DESPITE 100 ATTACKS, UNIT LEAVES AFGHAN WAR WITH NO CASUALTIES**

Mike Boettcher - Combat Outpost Lowell, Afghanistan - July 18, 2009—

Over the past year, the several dozen U.S. troops hunkered down in Combat Outpost Lowell have seen more firefights than any unit in Afghanistan.

The outpost is situated in rugged Afghan territory in Nuristan Province, close to the Pakistan border. Its job has been to disrupt al Qaeda and Taliban smuggling routes through the area.

Located on the northern part of Afghanistan's border with Pakistan, the troops in Combat Outpost Lowell did not see any reinforcements from the U.S. surge, which has been concentrated in southern part of the country.

But the Taliban has had a surge of its own, making July the bloodiest month of the Afghan war so far for U.S. troops. Part of the Taliban offensive was a determined effort to erase Lowell from the map. The Taliban attacked the outpost nearly 100 times in the past year.

But the men of Apache Troop, out of Fort Hood, Texas, are now heading home with a basketful of medals and the best victory they can think of -- they haven't lost a single soldier to enemy fire. <More at: [abcnews.go.com/International/story?id=8119034&page=1](http://abcnews.go.com/International/story?id=8119034&page=1)>

## **SOLDIER HELD IN AFGHANISTAN IS 23-YEAR-OLD IDAHOAN**

HAILEY, Idaho (AP) - A soldier from Idaho who disappeared from his base in Afghanistan has been captured, the Pentagon confirmed Sunday, a day after he was seen in a Taliban video posted online.

The Defense Department released the name of Pfc. Bowe (pronounced BOH) R. Bergdahl, 23, who was serving with an Alaska-based infantry regiment. The private was last seen walking away from his base near the border with Pakistan in an area known to be a Taliban stronghold.

Even before his name became public, two U.S. defense officials confirmed to The Associated Press that the man in that 28-minute video was the captured soldier. The video, in which Bergdahl said he was "scared I won't be able to go home," provided the first public glimpse of the missing American.

The Pentagon statement said Bergdahl's whereabouts became unknown on July 1 and his status was changed July 3 to missing-captured. <More at: <http://apnews.excite.com/article/20090719/D99HM1600.html>>

### **MILITARY COMMISSIONS EXPOSE DEEP DIVISIONS IN CONGRESS**

When Lt. Col. Darrel Vandeveld took up his job as a prosecutor for the Office of Military Commissions in Guantánamo Bay, Cuba, in May 2007, he was, he said, "a true believer" in his charge to bring to justice prisoners whom President Bush had deemed "the worst of the worst."

But what Vandeveld witnessed until he left his job in September 2008—including confessions obtained through torture, abusive interrogations, and "ugly attempts to cover up" the failures of the system—changed his mind. It also convinced the lawyer, a veteran of the wars in both Iraq and Afghanistan, that the military commissions are "broken beyond repair."

### **PENTAGON SEEKS TO OVERHAUL PRISONS IN AFGHANISTAN**

BAGRAM AIR BASE, Afghanistan — A sweeping United States military review calls for overhauling the troubled American-run prison here as well as the entire Afghan jail and judicial systems, a reaction to worries that abuses and militant recruiting within the prisons are helping to strengthen the Taliban.

In a further sign of high-level concern over detention practices, Adm. Mike Mullen, the chairman of the Joint Chiefs of Staff, sent a confidential message last week to all of the military service chiefs and senior field commanders asking them to redouble their efforts to alert troops to the importance of treating detainees properly.

The prison at this air base north of Kabul has become an ominous symbol for Afghans — a place where harsh interrogation methods and sleep deprivation were used routinely in its early years, and where two Afghan detainees died in 2002 after being beaten by American soldiers and hung by their arms from the ceiling of isolation cells.

## **2ND KY. WIDOW SETTLES SUIT OVER HUSBAND'S VA DEATH**

EAST ST. LOUIS, Ill. (AP) — The second of two Kentucky widows has settled her federal lawsuit over surgical care they say killed their husbands at an Illinois Veterans Affairs hospital where major surgeries have been halted for nearly two years after a spike in patient deaths.

Terms of Darla Marshall's April settlement over 61-year-old James Marshall's July 2007 blood infection death six days after his lymph node biopsy at the VA hospital in Marion were not disclosed in online court records. The Benton, Ky., widow had sought \$10 million in her wrongful-death lawsuit, filed here in April of last year.

Another widow, Katrina Shank of Murray, Ky., last year settled for \$975,000 her lawsuit involving Robert Shank III, an Air Force veteran who was 50 when he bled to death in 2007 a day after undergoing gallbladder surgery at the Marion site. Katrina Shank had sought \$12 million in damages.

Both were patients of surgeon Jose Veizaga-Mendez, who resigned in August 2007 three days after Shank died.

Within a month of Shank's death, surgeries at the Marion site — which serves veterans from southern Illinois, southwestern Indiana and western Kentucky — were halted after the VA found that at least nine deaths between October 2006 and March 2007 were "directly attributable" to substandard care there.

## **ARMY: SOLDIERS IN SLAYINGS FACED INTENSE COMBAT**

FORT CARSON, Colo. (AP) -- The psychological trauma of fierce combat in Iraq may have helped drive soldiers in a single battle-scarred Army unit to kill as many as 11 people after their return home, the military said Wednesday.

In a report billed as the most comprehensive examination to date of violent crimes and combat exposure, an Army task force of medical experts looked at members of Fort Carson's 4th Brigade Combat Team, 4th Infantry Division, known as the Iron Eagles.

Soldiers in the unit were accused in five killings in separate attacks around Colorado Springs in 2007 and 2008, including the slaying of a couple gunned down while posting a garage-sale sign. ### **SOUTH VIETNAMESE VET MEMORIAL KEPT OUT OF PARK**

A group of Wichita-area American veterans agreed Sunday to back a proposed compromise that would keep a memorial to South Vietnamese soldiers out of a downtown Wichita park.

A one-hour meeting on the issue drew about 60 people to the American Legion Post 136 in Mulvane. Those who attended voted overwhelmingly to support the proposal.

"We achieved everything that we set out to achieve," said John Wilson, of the Kansas Veterans Action Committee, a group that has opposed the memorial at the park.

Dennis Scuffham, who also opposes the memorial at the park, said he was willing to accept the compromise, in part, because "I don't know if it's going to get any better than this or not."

"We've done our job," he said. "...It's not in our park."

The Vietnamese Community of Wichita has raised money for a memorial to honor soldiers who fought alongside American troops against Communist North Vietnam during the Vietnam War.

But plans to put the memorial in Veterans Memorial Park in downtown Wichita drew the objections of many people. Among their objections: The park is meant to memorialize U.S. military veterans.

### **AUDITORS: PRIVACY LACKING AT SOME VA HOSPITALS**

WASHINGTON (AP) — Veterans Affairs Department hospitals and clinics aren't always making sure women veterans have privacy when they bathe and receive exams, government auditors said Tuesday.

As thousands of women veterans return from Iraq and Afghanistan and enter the VA's health system, the Government Accountability Office reported that no VA hospital or outpatient clinic under review is complying fully with federal privacy requirements.

GAO investigators found that many VA facilities had gynecological tables that faced the door — including one door that opened to a waiting room. It also found instances where women had to walk through a waiting area to use the restroom, instead of it being next to an exam room as required by VA policy. Researchers wonder if burn pits sped disease development

When Army Staff Sgt. Danielle Nienajadlo arrived at Joint Base Balad, Iraq, in April 2008, she had a clean medical history and recent blood work to prove it.

But three months later, after weeks of muscle fatigue, nausea, headaches and coughing up black phlegm, she went to the base emergency room after she spent a night vomiting and in pain. On July 26, 2008, she was diagnosed with acute myeloid leukemia.

"I am now a number, a statistic, a secret that no one wants to face," she told Military Times last fall. "I know that I got my disease in Iraq." The 32-year-old mother of three died March 20.

Her case, and those of 70 other cancer victims who contacted Military Times or Disabled American Veterans in recent months, have left experts debating whether their leukemias and lymphomas could have developed so quickly.

Robert W. Briggs, a former Army sergeant, was severely injured in Iraq and needs constant monitoring because of traumatic brain injury, blindness in one eye and paralysis on one side. He walks with the help of a service dog. Briggs gave up her job as a veterinarian technician to care for him and their two kids.

With tissue in hand, Michelle Briggs huddled Monday in a hotel conference room with 15 other caregivers who shared hugs and exchanged stories. They will go to Capitol Hill this week with a message to Congress: We need help.

### **VETERANS WITH PTSD AT HIGH RISK FOR DEMENTIA**

A University of California- San Francisco study has shown a [positive correlation between veterans with Post-Traumatic Stress Disorder \(PTSD\) and dementia](#). The study, led by Professor of Psychiatry Dr. Kristine Yaffe, analyzed records of over 180,000 veterans (127,000 with no PTSD and 53,000 with PTSD) that had no record of dementia between 1997 and 2000. Veterans were all over 55 years old, with the average age of 68 and nearly all male. [A similar study] suggested a reverse effect: [dementia may activate dormant PTSD](#).

### NATIONAL GUARD AND RESERVE ACTIVATED AS OF JULY 21, 2009

This week the Navy, Air Force and Coast Guard announced increases in activated reservists, while the Army and Marine Corps announced a decrease. The net collective result is 86 more reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 111,226; Navy Reserve, 6,514; Air National Guard and Air Force Reserve, 16,498; Marine Corps Reserve, 8,313; and the Coast Guard Reserve, 702. This brings the total National Guard and Reserve personnel who have been activated to 143,253, including both units and individual augmentees. ### NAVY VET HONORED, FOILED ISRAELI ATTACK

What's the difference between murder and massacre?

The answer is Terry Halbardier, whose bravery and ingenuity as a 23-year-old Navy seaman spelled the difference between the murder of 34 of the USS Liberty crew and the intended massacre of all 294.

The date was June 8, 1967; and for the families of the 34 murdered and for the Liberty's survivors and their families, it is a "date which will live in infamy" — like the date of an earlier surprise attack on the U.S. Navy.

The infamy is two-fold: (1) the Liberty, a virtually defenseless intelligence collection platform prominently flying an American flag in international waters, came under deliberate attack by Israeli aircraft and three 60-ton Israeli torpedo boats off the coast of the Sinai on a cloudless June afternoon during the six-day Israeli-Arab war; and (2) President Lyndon Johnson called back carrier aircraft dispatched to defend the Liberty lest Israel be embarrassed — the start of an unconscionable cover-up, including top Navy brass, that persists to this day.

Given all they have been through, the Liberty survivors and other veterans — who joined Halbardier to celebrate his belated receipt of the Silver Star — can be forgiven for having doubted that this day would ever come.

In the award ceremony at the Visalia (California) office of Rep. Devin Nunes, the Republican congressman pinned the Silver Star next to the Purple Heart that Halbardier found in his home mailbox three years ago.

Nunes said, "The government has kept this quiet I think for too long, and I felt as my constituent he [Halbardier] needed to get recognized for the services he made to his country."

Nunes got that right. Despite the many indignities the Liberty crew has been subjected to, the mood in Visalia was pronouncedly a joyous one of Better (42 years) Late Than Never. ### **DISABLED VETS LOSING BENEFITS IN DIVORCE SETTLEMENTS**

Across the country, unbeknownst to most Americans, many disabled veterans find themselves fighting a war they shouldn't have to be fighting and they need some help. The issue at stake is the inclusion of disability benefits in the calculation of divorce settlements, where judges – on many occasions – have ignored existing federal law (USC Title 38; Section 5301).

This federal law states:

"Payments of benefits due or to become due under any law administered by the Secretary shall not be assignable except to the extent specifically authorized by law, and such payments made to, or on account of, a beneficiary shall be exempt from taxation, shall be exempt from the claim of creditors, and shall not be liable to attachment, levy, or seizure by or under any legal or equitable process whatever, either before or after receipt by the beneficiary."
